

RELEASE AND INDEMNITY AGREEMENT

To induce the Androscoggin County Fish & Game Association (hereinafter the "Association") to permit the undersigned (hereinafter "Releasor") a limited and occasional use of the Association's premises, and to participate with the use of firearms and events sponsored by the Association, the Releasor hereby agrees to release and forever discharge the Association, its officers, directors, employees, agents, members and their heirs, executors, administrators, successors and assigns (hereinafter "Releasees") from all liability that arises directly or indirectly from Releasees' alleged negligence, including any and all claims, demands, damages, actions, cause of action or suits of any kind or nature whatsoever, and particularly on account of all injuries, known and unknown, both to person and property, which Releasor may sustain while on the Association's premises and/or participating in any event sponsored by the Association, including but not limited to any injury or damage relating to the use of any firearm.

Releasor further agrees to hold Releasees harmless from and to defend and indemnify Releasees against any now pending or subsequently initiated suits, claims, judgments, costs or expenses of any kind, including attorneys fees, contribution and/or indemnification by any other person or organization (or for subrogation by an insurer of such person or organization) on account of judgment, assertion or settlement of any claim asserted by or on behalf of Releasor as a result of the injuries or damages allegedly sustained by Releasor arising out of Releasor's use of Association's premises or participation in any Association sponsored event.

Releasor acknowledges and agrees that firearms usage and other potentially dangerous activities take place on the Association's premises and at Association sponsored events off the premises. Releasor agrees to exercise due care at all times while on the Association's premises and participating in Association's events and to abide by the Association's rules and instructions. Releasor understands and agrees that the Association may at anytime require the Releasor to leave the Association premises and/or be terminated from participating in any Association sponsored event with or without cause.

Releasees hereby expressly reserve unto themselves any rights which would be available to them but for this release to claim against, make claim against or sue any person, firm or corporation, whether or not said person, firm or corporation be a party to this release, as a result of any injuries or damages claimed by Releasor.

Releasor expressly acknowledges that this release and indemnity agreement is intended to be as broad and inclusive as permitted by law and that if any provision of this release and indemnity agreement is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired. No remedy conferred by any of the specific provisions of this release and indemnity agreement is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of anyone or more remedy hereunder by Releasees shall not constitute any waiver of Releasees' right to pursue any other available remedies. This agreement binds Releasor and his/her heirs, executors, administrators, personal representatives, agents or assigns.

Releasor acknowledges and agrees that Releasor has read this agreement and he/she understands its terms and is executing this agreement voluntarily. Releasor also acknowledges that he/she has read, understands and will at all times abide by all range rules and procedures and any other rules and instructions stated by the Association.
